

DESCRIPTION

A parcel of land being Lot 1 of a Certified Survey Map recorded in Volume 11, Page 3093, located in the Northwest ¼ of the Southeast ¼ of Section 12, Township 28 North, Range 15 West, Town of Cady, St, Croix County, Wisconsin, more fully described as follows:

Commencing at the East Quarter Corner of said Section 12;

Thence South 88°43'25" West, along the east-west quarter section line, 1343.31 feet to the northeast corner of said Lot 1 and the POINT OF BEGINNING;

Thence South 00°16'36" East, 663.01 feet to the southeast corner of said Lot 1;

Thence South 88°33'07" West, 1340.83 feet to the west line of said Northwest ¼ of the Southeast ¼;

Thence North 00°29'46" West, along said west line, 666.99 feet; Thence North 88°43'25" East, 1343.31 feet to the point of beginning.

Contains 20.49 acres. Subject to right of way for 325th Street as shown and subject to a 66 foot wide roadway easement. Also subject to any and all additional easements, right of ways or conveyances of record.
