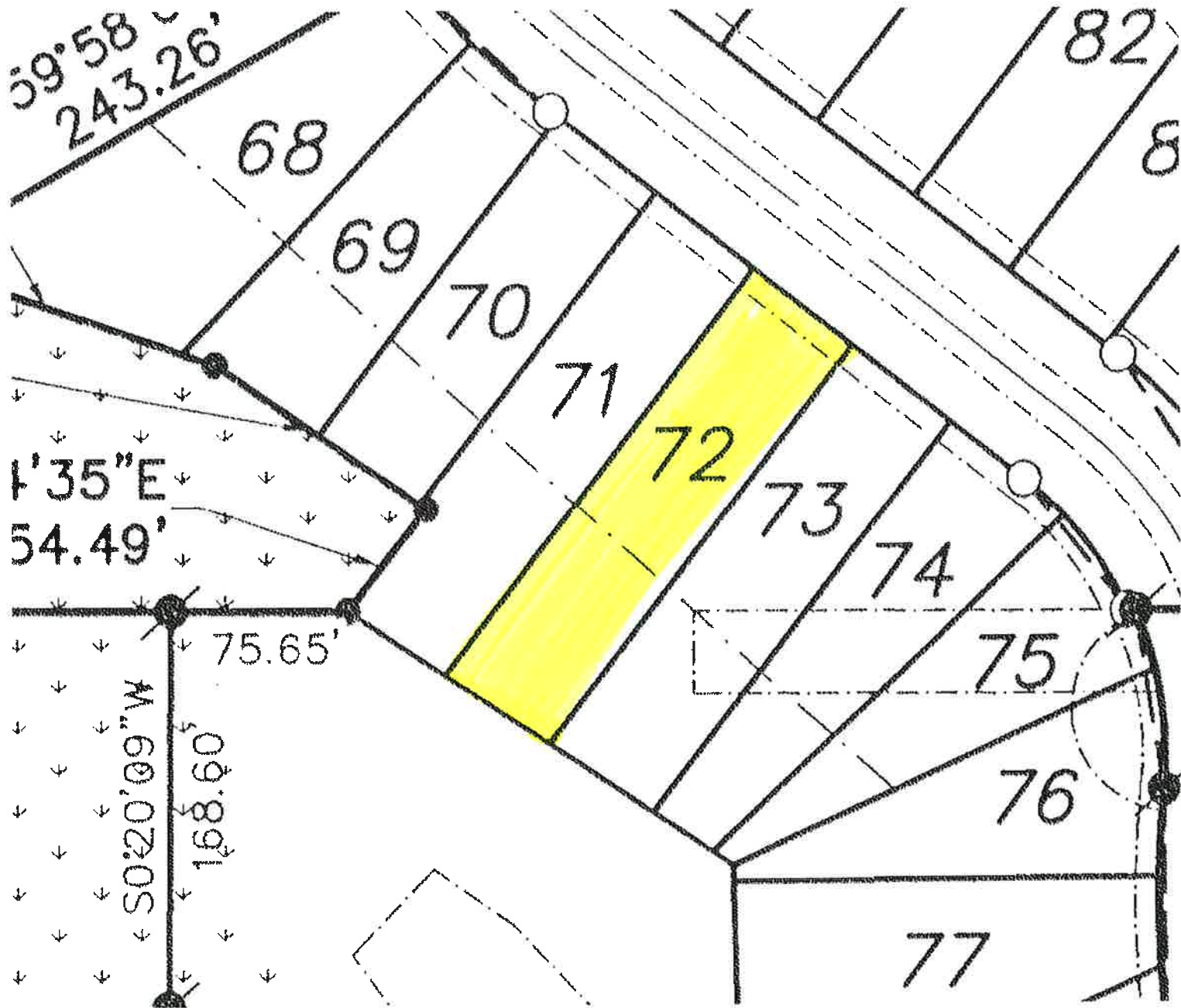
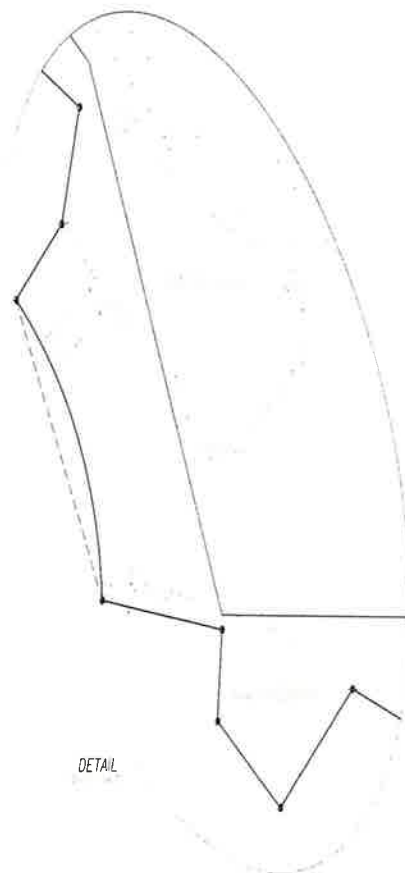
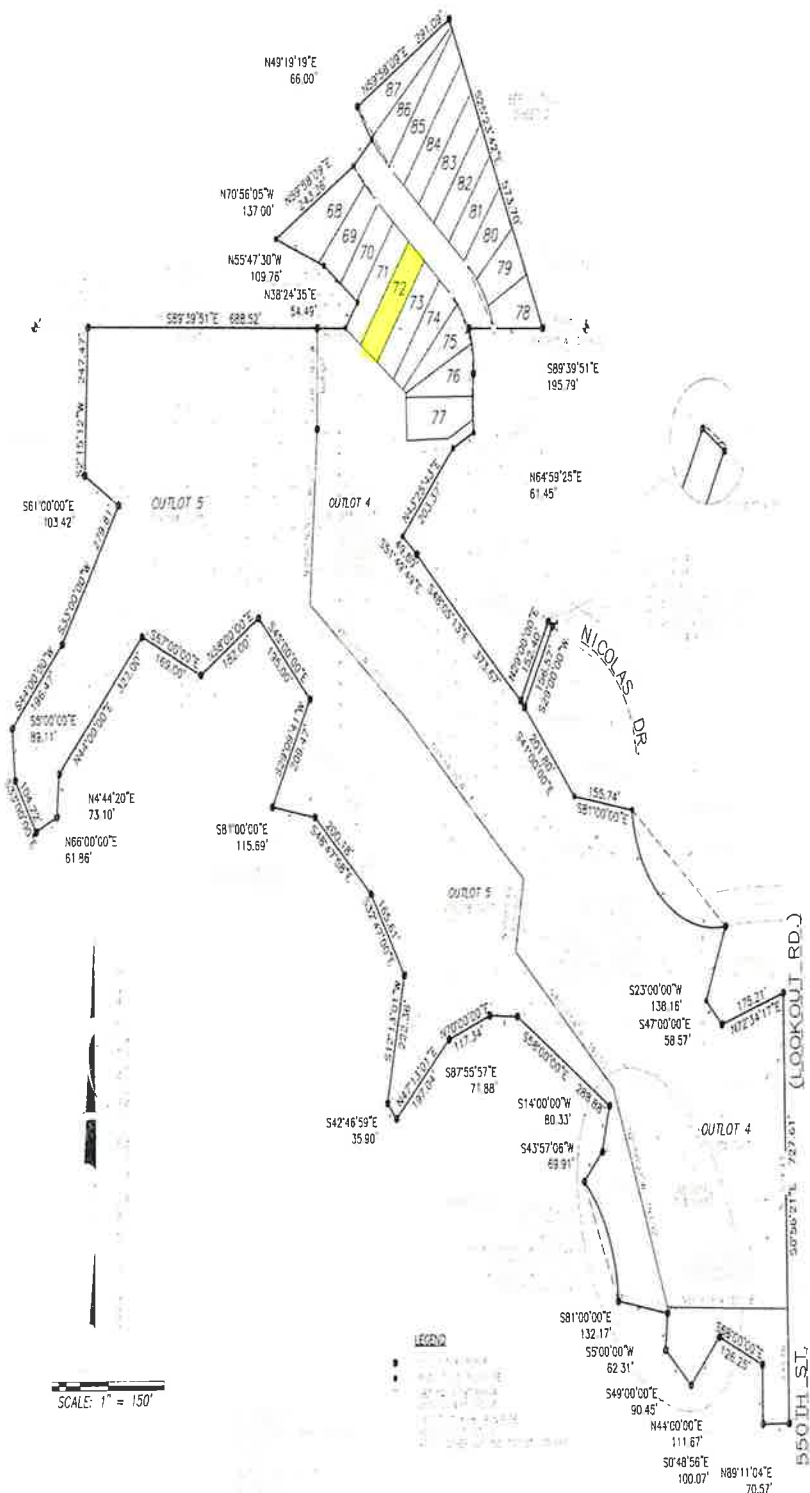
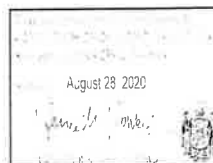






LOCATION SKETCH



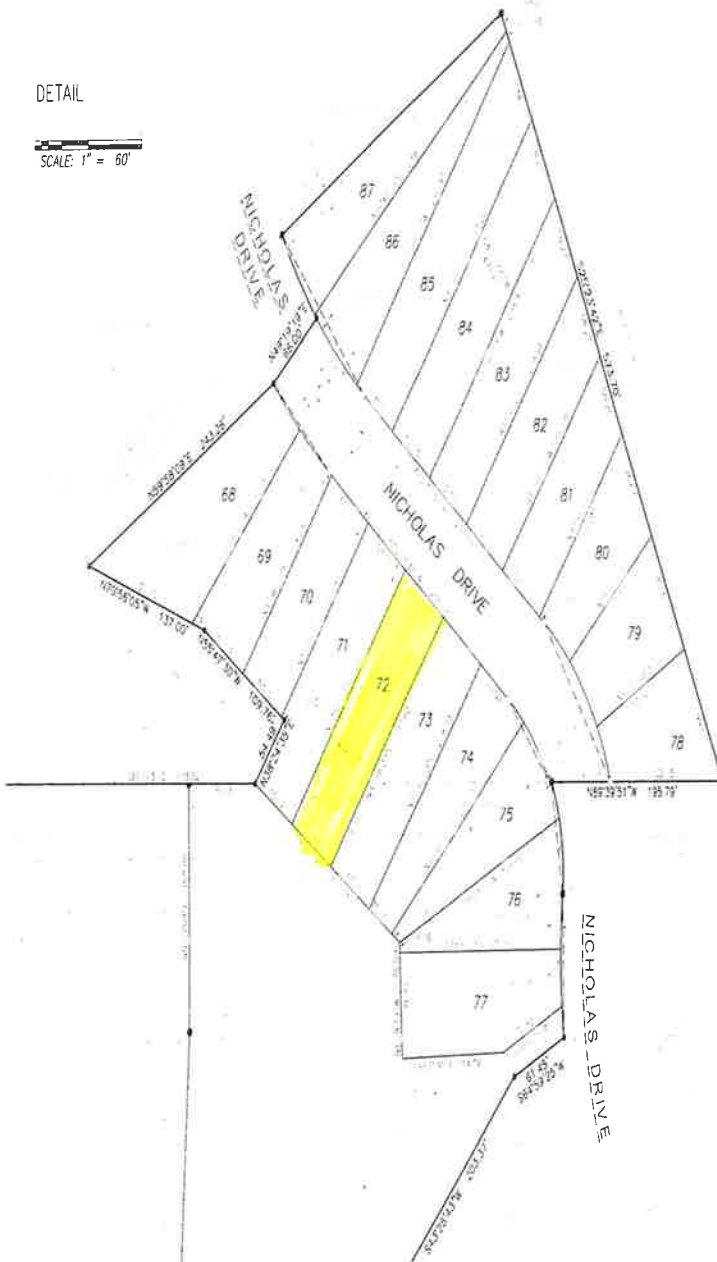
