VILLENEUVE, REGISTERED LAND SURVEYOR, Route #6 Box 150, Menomonie, Wisconsin 54751 hereby certify that I have surveyed, divided and mapped Lot 9, 10 and 11 of Park Rapids Addition, Town of Red Cedar, Dunn County, Wisconsin located in Government Lot 7, Section Six (6), Township Twenty-eight (28) North, Range Twelve (12) West, Town of Red Cedar, Dunn County, Wisconsin described as follows:

Commencing at the Northwest corner of Lot 9 in said Park Rapids Addition for the point of beginning of the parcel herein described;

thence on an assumed bearing of South  $88^{\circ}$  14, 00" East, along the North line of said Lct 9, a distance of 591.45 feet to an iron pipe meander corner;

thence continuing South 88° 14' 00" East, along said North line, 75 plus or minus feet to the Westerly shoreline of the Red Cedar River;

thence North 88° 14' 00" West, along said North line, 75 plus or minus feet to the above called for iron pipe meander corner;

thence South 03° 13' 30" East, along the meander line 328.23 feet to an iron pipe meander corner;

thence South 880 14' 00" East, along the South line of Lot 11, a distance of 113 plus or minus feet to said Westerly shoreline;

thence North 88° 14' 00" West, along said South line, 113 plus or minus feet to the above called for iron pipe meander corner;

thence continuing North 88° 14' 00" West, along the South line of Lot 11, a distance of 404.48 feet to an iron pipe;

thence along the arc of a curve, concave Westerly for an arc distance of 16.84 feet, a chord bearing of North  $31^{\circ}$  23' 12.5" West and a chord length of 16.84 feet;

thence North 32° 15' 00" West, 88.30 feet to an iron pipe;
