Commencing at the West 1/4 corner of Section Fifteen (15), Township Twenty-nine (29) North, Range Twelve (12) West, Town of Tainter, Dunn County, Wisconsin;

thence on an assumed bearing of North 89° 39' 26" East, along the North line of Government Lot 4, a distance of 1313.44 feet to an iron pipe at the Northeast corner of Government Lot 4;

thence South 25 plus or minus feet to the Northerly shore of Lake Tainter; thence North 25 plus or minus feet to said Northeast corner of Government Lot 4; thence South 86° 50' 15" West, along a meander line, 194.15 feet to an iron pipe; thence South 58° 49' 08" West, along the meander line 157.31 feet to an iron pipe;

thence South 46° 03' 22" West, along the meander line 319.71 feet to an iron pipe; thence South 37° 50' 32" West, along the meander line 202.28 feet to an iron pipe; thence North 88° 00' 03" West, along the meander line 222.40 feet to an iron pipe; thence South 85° 17' 24" West, along the meander line 63.42 feet to an iron pipe and said meander line there terminating;

thence South 02^{0} 10' 17" West, 30 plus or minus feet to the Northerly shore of Lake Tainter;

thence North 02° 10' 17" East, 30 plus or minus feet to the iron pipe termination of the meander line;
