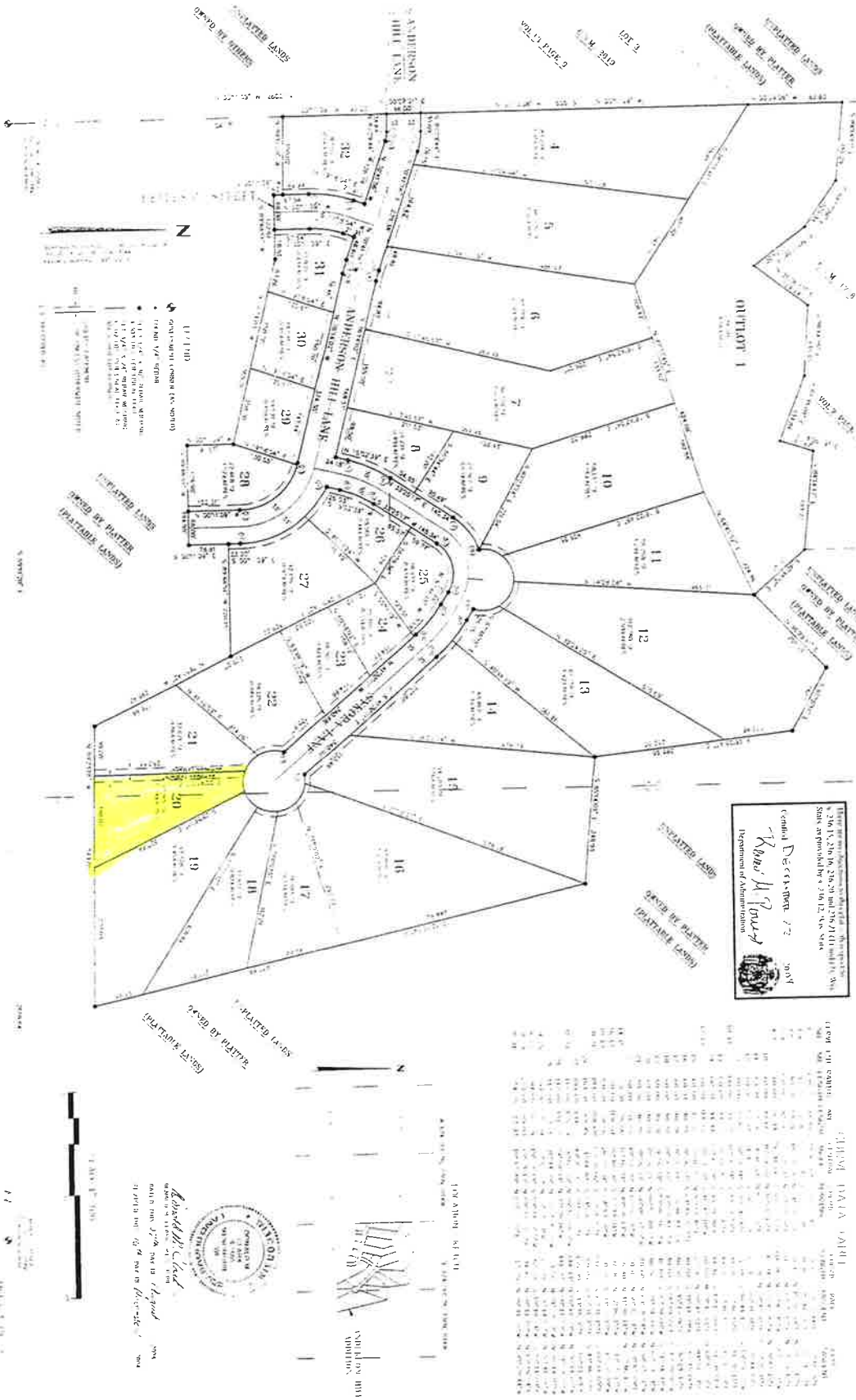


ANDERSON HILL ADDITION

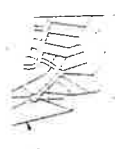
