

LEGAL DESCRIPTION FOR PARCEL "A"

BEING A PARCEL OF LAND LOCATED WITHIN THE NORTHEAST 1/4 OF THE NORTHWEST 1/4, AND WITHIN THE SOUTHEAST 1/4 OF THE NORTHWEST 1/4, ALL IN SECTION 22, TOWNSHIP 30 NORTH, RANGE 13 WEST, TOWN OF HAY RIVER, DUNN COUNTY, WISCONSIN: MORE FULLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTH 1/4 CORNER OF SAID SECTION 22; THENCE N89°39'38"W, ALONG THE NORTH LINE OF SAID NORTHWEST 1/4, 381.57 FEET TO THE NORTHEASTERLY CORNER OF LOT 1, CERTIFIED SURVEY MAP NUMBER 4889; THENCE, ALONG THE EASTERLY LINE OF SAID CERTIFIED SURVEY MAP NUMBER 4889, 393.43 FEET TO THE SOUTHEASTERLY CORNER OF LOT 2, OF SAID CERTIFIED SURVEY MAP NUMBER 4889;

THENCE S56°01'11"W, ALONG THE SOUTHERLY LINE OF SAID LOT 2, 42.09 FEET; THENCE S00°18'37"W 1563.26 FEET TO A POINT ON THE CENTERLINE OF C.T.H. "N"; THENCE S88°52'06"E, ALONG SAID CENTERLINE 62.61 FEET; THENCE N00°31'15"E 33.00 FEET TO A POINT ON THE NORTHERLY RIGHT OF WAY LINE OF SAID C.T.H. "N";

THENCE N84°10'15"E, ALONG SAID NORTHERLY RIGHT OF WAY LINE, 153.65 FEET; THENCE, ALONG SAID NORTHERLY RIGHT OF WAY LINE, ALONG A CURVE TO THE RIGHT, SAID CURVE HAVING A RADIUS OF 868.51 FEET, A CENTRAL ANGLE OF 16°24'39", AND WHOSE LONG CHORD BEARS S81°16'16"E FOR A DISTANCE OF 247.91 FEET, TO A POINT ON THE NORTH SOUTH 1/4 LINE OF SAID SECTION 22;

THENCE N00°18'37"E, ALONG SAID NORTH SOUTH 1/4 LINE, 1965.46 FEET
